## FULL PRIVACY NOTICE

### 1. WHAT INFORMATION DO WE COLLECT?

#### **Personal Information You Disclose to Us**

We collect personal information that you voluntarily provide when you:

- Express interest in our services.
- Participate in salon activities.
- Contact us.

#### **Collected Information Includes:**

- Names
- Phone numbers
- Contact preferences
- Debit/credit card numbers

#### **Sensitive Information:**

When necessary, with your consent or as permitted by law, we process:

- Payment details (debit/credit card numbers).

**Social Media Login Data:**

If you register via social media (Facebook, X, etc.), we receive profile information (name, email, profile picture, etc.).

**2. HOW DO WE PROCESS YOUR INFORMATION?**

We process your information to:

- **Provide services** (appointments, payments, support).
- **Send administrative info** (policy changes, service updates).
- **Send marketing emails** (opt-out available).
- **Improve our services** (analyze usage trends).
- **Comply with laws** and prevent fraud.

**3. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?**

We may share information:

- **During business transfers** (mergers, acquisitions).
- **With service providers** under strict contracts.

We **do not** sell or share data for marketing.

**4. HOW DO WE HANDLE YOUR SOCIAL LOGINS?**

If you register via social media:

- We receive profile data (name, email, etc.).
- We use it only as described in this policy.
- We do not control how social media platforms use your data.

**5. HOW LONG DO WE KEEP YOUR INFORMATION?**

We retain data only as long as necessary for:

- Business purposes.
- Legal compliance.
- Dispute resolution.

Afterward, we delete or anonymize it.

## **6. HOW DO WE KEEP YOUR INFORMATION SAFE?**

We implement security measures, but no system is 100% secure. You use our Services at your own risk.

## **7. DO WE COLLECT INFORMATION FROM MINORS?**
